## 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (Phone eg. Australia 131 126; New Zealand 0 800 764766)

- Inhalation:** If fumes or combustion products are inhaled, remove from contaminated area. Other measures are usually unnecessary.
- Skin Contact:** If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water. If irritation continues, apply calcium gluconate gel and seek medical attention.
- Eye Contact:** If in eyes, hold eyelids apart and flush the eye continuously with running water. If irritation continues, seek medical attention.
- Ingestion:** Immediately give a glass of water. DO NOT induce vomiting. Contact a Poisons Information Centre (Australia 13 11 26, New Zealand 0800 764 766) or a doctor.
- Medical attention And special Treatment:** Treat symptomatically.

## 5. FIRE FIGHTING MEASURES

- Hazards from combustion Products:** Combustible. Not considered to be a significant fire risk. Expansion or decompression on heating may lead to violent rupture of containers.
- Precautions for fire fighters and Special protective equipment:** Alert Fire Brigade and tell them location and nature of hazard. Wear breathing apparatus plus protective gloves for fire only. Use fire fighting procedures suitable for surrounding area. DO NOT approach containers suspected to be hot. Cool fire exposed containers with water spray from a protected location. If safe to do so, remove containers from path of fire. Equipment should be thoroughly decontaminated after use.

## 6. ACCIDENTAL RELEASE MEASURES

<b>Emergency procedures:</b>	If contamination of sewers or waterways has occurred advise local emergency services.
<b>Methods and materials for Containment and clean up:</b>	Clear area of all personnel. Alert Fire Brigade and tell them location and nature of hazard. Control personal contact by using protective equipment as required. Prevent spillage from entering drains and waterways. Collect recoverable product into labeled containers for recycling. Absorb remaining product with sand, earth or vermiculite and place in appropriate containers for disposal. Wash area and prevent run off into drains or waterways.

<b>Conditions for safe storage:</b>	Store away from heat and oxidizing agents. Ensure containers are clearly labeled and keep securely sealed and protected against physical damage.

#### EYE
